

Bonus Policy

Bonus - is a partner's remuneration, the type and amount of which is determined by the Bonus policy.

Affiliate Case — a digital document that defines the partner's rights to rewards in accordance with the Agreement and this Bonus Policy.

User balance — the user's internal account used to account for bonuses.

The bonuses reflected on the user balance sheet are the property of the Company. Bonuses are accounted for in internal accounting units, equated to fiat or digital currencies for convenience of calculations. The User agrees that the bonuses reflected on the balances are not cash and under no circumstances can be considered financial liabilities. The Company is not a financial institution, does not provide users with financial services, does not operate with funds and financial instruments of users.

The Company does not open or maintain personal, settlement, savings, term or other accounts/deposits intended for transactions with real money or derivative financial instruments.

The exchange and accrual of bonuses are made only if the Company showed a profit in the reporting period.

Bonus accrual:

To accrue bonuses, the user must own at least one affiliate case. The company gives a free partner case to each user when registering on the Site. The user can purchase any number of partner cases of different denominations. Affiliate cases are not subject to sale or transfer to another user or the Company. The company accrues bonuses to the user's balance every reporting period in the presence of net profit.

Bonus exchange:

The Company determines the procedure for exchanging bonuses for goods/services of the Company and/or digital assets, and vice versa. The registration of the exchange of bonuses is carried out using the interface in the online store, using the available option provided by the Seller. The minimum and maximum amount of bonus exchange depends on the conditions of the selected option, as well as on the price of the product/service and/or digital asset.

The opportunity to exchange bonuses for an asset selected by the user is provided once during the reporting period, if there is a net profit. The user can also transfer bonuses to other users instantly and without commissions, if technically possible.

In the absence of the Company's net profit, bonus exchange operations are not performed.

Bonus types:

1. The bonus from the trader - is a reward for inviting traders.

You get \$10 every time a trader you refer pays for a test to get a managed account. With this bonus, the trader stimulates your partner activity and gets the opportunity to receive the company's capital for management.

2. Profit bonus - is a reward for purchasing an affiliate case.

Profit bonus is a percentage accrued on the cost of each of your affiliate cases. The size of the profit bonus depends on the net profit of the company. If there is no profit in the reporting period, then the profit bonus is not accrued, and the validity period of the partner case is extended for one reporting period.

The profit bonus can be increased if the user bought CASE service tokens after 12/01/2022 and saves them in his personal account: in the amount of 10,000 tokens - by 1%; in the amount of 50,000 tokens - by 2%; in the amount of 100,000 or more tokens tokens - by 3% for the reporting period.

3. Affiliate bonus - is a reward for referrals.

Affiliate Bonus is credited simultaneously with the Profit Bonus. This is the percentage calculated from the profit bonus of your affiliate structure from three levels. The size of the affiliate bonus depends on the value of your senior affiliate case:

- 3.1. If there is an active case with a value of 0 (free case) = 7% of the profit bonus of the 1st level;
- 3.2. If there is an active case with a value of 1000 = 10% of the profit bonus of the 1st level and 5% of the profit bonus of the 2nd level;
- 3.3. If there is an active case with a value of 5000 = 15% of the profit bonus of the 1st level, 7% of the profit bonus of the 2nd level, 3% of the profit bonus of the 3rd level.
- 3.4. If there is an active case with a value of 10000 = 20% of the profit bonus of the 1st level, 10% of the profit bonus of the 2nd level, 5% of the profit bonus of the 3rd level.
